REGULATIONS ESTABLISHING THE ADMISSION POLICIES
FOR APPLICATIONS FOR SENIOR CITIZENS' HOUSING IN THE
VILLAGE OF ROSEMONT, ILL.

A. SENIOR HOUSING IS ALLOWED ONLY FOR THOSE 60 YEARS OF AGE OR OLDER

1. THE ONLY EXCEPTION TO THE ABOVE STATED CRITERIA OF ADMISSION TO THE ROSEMONT SENIOR CITIZENS HOUSING SHALL BE FOR SPOUSES OF APPLICANTS WHO MEET THE AGE REQUIREMENT.

B. THE ADMISSION REQUIREMENTS TO THE ROSEMONT SENIOR CITIZENS HOUSING SHALL NOT INCLUDE ANY LIMITS OR OTHER REQUIREMENTS WITH RESPECT TO AGGREGATE INCOME FOR A SINGLE ELDERLY OR FOR A TWO PERSON ELDERLY FAMILY. FURTHER, THERE SHALL BE NO LIMITS OR OTHER REQUIREMENTS REGARDING TOTAL ASSETS, EITHER FOR A SINGLE ELDERLY OR FOR A TWO PERSON ELDERLY FAMILY.

C. PREFERENCES FOR OCCUPANCY SHALL BE GRANTED TO OTHERWISE ELIGIBLE APPLICANTS WHO MEET THE ABOVE CRITERIA IN ACCORDANCE WITH THE FOLLOWING:

- 1st PREFERENCE – PERSONS WHO HAVE RESIDED IN THE VILLAGE OF ROSEMONT FOR A PERIOD OF NOT LESS THAN ONE YEAR INCLUDING ALL “ELIGIBLE EMPLOYEES” INCLUDED IN THE HOUSING POLICY.
- 2nd PREFERENCE – THE PARENT OR PARENTS OF CHILDREN WHO HAVE RESIDED IN THE VILLAGE OF ROSEMONT FOR A PERIOD OF NOT LESS THAN TWO YEARS.
- 3rd PREFERENCE – PERSONS WHO HAVE RESIDED IN LEYDEN TOWNSHIP FOR A PERIOD OF NOT LESS THAN TWO YEARS.

D. VERIFICATIONS OF APPLICANT AND TENANT'S STATEMENTS ... APPLICANTS AND TENANTS SHALL BE REQUIRED TO FURNISH PROOF OF THEIR STATEMENTS WHEN REQUESTED BY MANAGEMENT TO REASONABLY ASSURE THE ACCURACY THEREOF.

E. BEGINNING MARCH 1, 2019 ALL RENT WILL BE DONE BY AUTO WITHDRAWAL.

E. SINGLE SENIORS QUALIFY FOR A ONE-BEDROOM APARTMENT. COUPLES QUALIFY FOR A TWO-BEDROOM APARTMENTS WITHIN THE COMPLEX.

SENIOR HOUSING AT THE COMPLEX OFFERS SENIORS A CHANCE TO LIVE MORE INDEPENDENTLY DUE TO LOWER RENTAL RATES. THERE ARE NO NURSING FACILITIES OR MEDICAL FACILITIES AT THE COMPLEX. SENIORS WHO CANNOT TAKE CARE OF THEMSELVES CANNOT BE CONSIDERED FOR AN APARTMENT. IF A SENIOR BECOMES UNABLE TO CARE FOR HIM OR HERSELF, IT IS THE RESPONSIBILITY OF THEIR FAMILY TO MAKE OTHER LIVING ARRANGEMENTS. VISITING NURSES ARE ALLOWED AFTER SURGERY OR FOR THERAPY.
